Hostel will be allotted as per first come first serve basis as we have limited seats (only 28) for first year. Student needs to be present at college for allotment along with below docs:

- Duly filled application form
- Antiragging self-declaration
- Fee Receipt

Rules and regulations of Girl's Hostel:

- Exchange of rooms and unauthorized occupancy are illegal. If any student does so, her allotment will be cancelled with a fine of rupees two thousand.
- After hostel allotment, if any student wants to quit hostel, then she has to pay minimum one year of hostel fee.
- Ragging in any form is banned by the honorable Supreme Court of India. Any student found indulged in ragging shall be dealt under law.
- Students of the hostel are hereby informed that they themselves are responsible for their belongings. Hostel administration/institute administration will not be responsible for loss of their belongings.
- The closing time of the hostel is 06:30pm (Nov to March) in winter season and 07:30pm (April to Oct) in summer season. If a student is coming late by any chance, has to do her entry in "late coming register". The student's allotment will be cancelled if she is coming late for more than three days in a season (summer/winter).
- If a student wants to go out before 06:00am and after 07:30pm in summer season (06:30pm in winter season), she will have to take prior permission (previous working day) from the warden/asst. warden in written otherwise she will not be allowed to go, no matter what the case is.
